




Over 1.05 lakh hospital admissions authorised under portability of services



National call centre 14555 was set up by National Health Authority on 24th August 2018





## Health Related Steps taken so far for COVID containment (1/3)





#### Proactive, pre-emptive and graded response:

- Advisories as per evolving situation
- Technical guidance for Quarantine, Surveillance, Containment, Testing and Treatment, hospital infection prevention etc.



Strengthened testing capacity (> 1 lakh tests per day)



## Expanding infrastructure - COVID Dedicated Hospitals

- 1054 Dedicate Covid Hospitals: 1.81 lakhs beds
- 2681 Dedicated Covid Health Care Centre: 1.50 lakh beds
- 7292 Covid Care Centres 6.62 lakh beds
- Total of 9.96 lakh dedicated beds as on 29.5.2020



### Health Related Steps taken so far for COVID containment (2/3)





#### Ensuring logistics - supplies of essential items

 PPEs (51 lakhs, more than 300 suppliers identified), N95 masks (87 lakhs, 7 suppliers), HCQ tablets (11.08 Cr, 2 suppliers)



Comprehensive Guidance on non-COVID essential services such as Blood collection/transfusion, dialysis, chemotherapy, Deliveries




#### Financial arrangements:

- India COVID-19 Emergency Response Package ₹15000 Cr
- Rs 4113 Cr released to states, Rs. 6175 cr for essential items,
   ₹2200 Cr for testing labs and kits
- Untied funds to Districts for handling emergency requirements
- Insurance cover of Rs 50 lakhs per person for health professionals under Pradhan Mantri Garib Kalyan Yojana



## Health Related Steps taken so far for COVID containment (3/3)





#### Leveraging IT -

- Roll out of e-Sanjeevani Tele-Consultation Services
- MCI Guidelines issued
- Training and capacity building: Virtual learning modules iGOT platform
- Arogya Setu for Surveillance



#### Legal framework -

- Invoking Disaster management Act as per situational needs
- Amendment in Epidemic Diseases Act to protect healthcare service personnel and property
- 1075 help line activated 24.50 lakh calls attended



## Ban on e-Cigarettes





India is one of the few countries that has banned e-cigarettes through a separate legislation



A pre-emptive measure to protect a whole generation of children and youth from nicotine addiction



### Surakshit Matritva Aashwasan (SUMAN)





Surakshit Matritva Aashwasan (SUMAN) launched on 10th October 2019



Aims to end all preventable maternal & newborn deaths and morbidities and provide a positive birthing experience



To provide assured, dignified, respectful & quality healthcare, at no cost and zero tolerance for denial of services for every woman and newborn visiting the public health facility



## Improving Child Health (1/2)





Full Immunization Coverage (FIC) in 2019-20 - 91.16 %



Expansion of Rotavirus Vaccine (RVV) to the entire country: to reduce mortality & morbidity caused by Rotavirus diarrhoea - one of the 100 days priority agenda



Intensified Mission Indradhanush (IMI) 2.0 -

- To reach the unreached and partially vaccinated children in 381 districts across 29 States/ UTs
- 37.09 lakh children and 7.41 lakh pregnant women vaccinated



## Improving Child Health (2/2)





Social Awareness and Actions to Neutralize Pneumonia Successfully (SAANS)



SAANS was launched on 16th November 2019 to accelerate action to reduce deaths due to childhood pneumonia




Rashtriya Bal Swasthya Karyakram (RBSK)

- 12.7 Crore children (0-18 yrs. age) were screened
- 1.27 Crore children were identified with any of 4 Ds (Defect at Birth, Deficiencies, Diseases and Developmental Delays)
- 65.0 lakh children availed services at secondary/tertiary care facilities



## TB Harega Desh Jeetega (1/2)





Commitment at highest level to End TB by 2025



24 lakh cases detected in 2019 - gap between estimated and detected cases reduced from 10 lakh cases to 2.9 lakh cases



Molecular diagnostics in all districts – 1180 CBNAAT and 1869 TRUNAT machines – Also contributing to COVID-19 testing



Active case finding - 27.4 crore vulnerable population screened for TB



JEET (Joint Effort for Elimination of TB) initiative for private sector engagement in 173 cities and 348 district

#### Community engagement -

- State and District TB Forums in all districts
- More than 4 lakh TB treatment supporters



## Nikshay Poshan Yojana – supplementary nutrition to TB patients
